Canadian checks must be marked "Payable in U.S. funds." There will be a \$20.00 service charge for returned checks. Make checks payable to the *AMERICAN SIAMESE CAT CLUB*. Closing Date: April 12, 2007 or as determined by the entry clerk. SALES or DOUBLE CAGES: \$10.00 per day, 1 cat or 2 kittens per cage. Please reserve at time of entry. Single cages are 22" X 22" and 25" high. End of Row: \$5.00 per day (N/C for handicapped). Substitution Fee: \$5.00. BENCHING: will begin at 7:30 a.m. on both days, and cats must be benched by 8:30 a.m. Judging will begin promptly at 9:00 a.m. *Exhibitors checking in after 8:30 a.m. must go to each ring and inform the clerk of their presence or any changes*. All cats must remain in the show hall until 4:00 p.m. both days. We will try to accommodate benching requests on cats entered both days only. Please limit requests to two names. SUPPLIES: People food will be available. Cats: Please bring food & your own litter & pan. Swheat Scoop Litter & disposible litterboxes will be provided. HOTEL: Show hotel is the Holiday Inn Express - 352 North Street - Saco, Maine. Phone 207-286-9600. Room rates are \$69.99 plus tax, but you must mention that you are with the CAT SHOW. Rooms rates guaranteed until March 30. There is a free breakfast being offered at the hotel, both days! PLEASE see that all claws are clipped (back and front) and vaccinations are up to date. No declawed cats allowed. Kittens must be four months of age to compete. Kittens for sale must be three months old and have a valid CFF litter slip. There will be no veterinary inspection prior to entering show hall. HOUSEHOLD PETS: will be judged in all rings as Allbreed. All HHPs over eight months old MUST be spayed or neutered. All CFF registered HHPs are P.O.P. scored. Special Prizes for the highest scoring pointed cats.

It is the responsibility of the exhibitor to be certain that cats are correctly entered and are eligible for competition in CFF.
