**ENTER EACH SHOW SEPARATELY. Make checks payable to Greater St. Louis Cat Club for Saturday's show. GSLCC does not take PayPal. Make checks payable to America's Heartland for all of Sunday's show entry fees. AHL will take PayPal send payments to [tgifclub@swbell.net](mailto:tgifclub@swbell.net) with America's Heartland in the notes field.**

**Closing Date For Both Shows:** Tuesday 4/23/12 @ 9pm EST or when each show fill with 225 entries.

**Entries:** It is the exhibitor's responsibility to confirm all online entries with the Entry Clerks; the clubs will not be responsible for misdirected entries. Per show rule 11.08 a.; each entry *must* be accompanied by stipulated entry fee. All online entries must be paid in full within 10 days of receipt or prior to start of show. All fees include CFA/Regional surcharges. No fax or phone entries and no calls to the Entry Clerks after 8 pm. **Odd numbered entries with ANY size Security cage requires double cage space. Cages will be provided, but not set up on cage bottoms.**

**Show Hall:** The Kennedy Complex, 6050 Wells Road (off Tesson Ferry Road) St. Louis, MO 63136 Phone: 314-894-3089. The show hall is handicapped accessible, non-smoking and air-conditioned. Parking is free. **Airport:** Lambert-St Louis International (STL) is about 28 miles/35 minutes away.

**Check in & Show Hours:** Check-in Saturday 8:30-9:30 am, Sunday 7:30-8:30 am. Judging will begin at 10:00 am on Saturday and at 9:00 am on Sunday. Advertized hours are 10:00 am to Finals on Saturday and 9 am to Finals on Sunday.

**Cages:** A single cage measures 21" x 21" x 21", a double cage measures 21" x 21" x 42". Bring litter pans & food, litter is provided.

**Rules:** It is advised that all entries be tested for FELV and be inoculated by a licensed veterinarian against Feline Panleukopenia, Rhinotracheitis, Calici Virus & Rabies before entry. Claws of all feet must be clipped prior to benching. No declawed cats allowed. All cats must be free of fleas, fungus, earmites, and any contagious illness. Show Management reserves the right to cause the removal of any cat from the show hall if any of the above until a licensed vet can make an examination at the exhibitor's expense. All championship, premiership and registered kitten entries will be scored for CFA regional and national awards. These shows will be conducted under current CFA rules. Rules are \$7 from CFA, 260 East Main St. Alliance, OH 44601.

**Liability:** Greater St. Louis Cat Club or America's Heartland will take reasonable care to safeguard property of exhibitors. Neither the clubs, it members or the Kennedy Complex will be liable for loss or damage. No guard will be on duty Saturday night, cats must be removed from show hall during the evening.
