ENTRIES: No refunds or substitutions may be made after closing date. No refunds will be given for failure to bench. Email Entry Clerk to confirm receipt of online/fax entries. Use of security cage requires two entries per cage (purchase of extra ½ cage space if only one cat entered). End of row is free to handicapped exhibitors (must request when submitting entry form). All entries include \$2 CFA surcharge. No kittens under the age of four months will be allowed in show hall. Make checks payable to Birmingham Feline Fanciers. There is a \$35 returned check fee. All online entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first (per CFA Show Rule 6.21). SHOW HALL: Zamora Temple, 3521 Ratliff Rd, Birmingham, AL 35210. Phone Number 205-956-3636. The show hall is heated and air-conditioned. Neither the Club nor Zamora Temple is liable for loss of property, damage, or accidents to cats or to exhibitors. No cats or kittens allowed in show hall overnight. Free Parking. BENCHING: Check-in will be from 7:30 - 8:45 a.m. on Saturday. Judging will begin at 9:00 a.m. on Saturday and Sunday. No cats will be permitted to leave show hall before posted show hours without the consent of show management. All claws of all entries must be clipped prior to benching. AWARDS/SCORING: Rosettes, ribbons, and scoring will be awarded in strictly in accordance with CFA Show Rules. All Championship, Premiership, registered kittens, recorded HHP and registered cats competing as HHP with an HHP color class prefix swill be scored for CFA National and Regional awards. A copy of show rules may be obtained from CFA by sending \$7.00 to The Cat Fanciers Association, 260 East Main Street, Alliance, OH 44601. HOUSEHOLD PETS: All kittens must be at least four months of age. No de-clawed HHP's may be entered. Cats over eight months of age must be spayed or neutered. For more information, contact Clare Hames @ 205-595-7050/205-915-1129 or gatahames@aol.com. SUPPLIES: Litter will be provided. Please bring your own litter boxes, pet food, and dishes. Single cages measure approximately 22x22x22. Exhibitors are responsible for material or cage curtains to cover the top, sides, and bottom of your cage. HEALTH AND SALES: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), reline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. State of Alabama requires Rabies vaccinations. The show committee reserves the right to remove any cat or kitten from the show hall if suspected of having any of the listed ailments until examined by a licensed veterinarian at the owner/agent's expense. Declawed cats are not eligible for entry. Sales cages only available with paid entries.
