Show Hall: The show will be held in the Holshouser Building on the NC State Fairgrounds, 1025 Blue Ridge Rd. Raleigh, NC 27607 PH: 919-821-7400. The building is heated and handicapped accessible. There is no smoking in the show hall.

Entry & Payment Info: Entries are accepted now. Entry Fees include CFA & Regional surcharges. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Coastal Paws Cat Club. **All payments at check-in must be CASH only.** No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. **Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE THE CLOSING DATE.**

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

Check in & Show Hours: Check in: Saturday 7:30-8:30 am. Sunday 7:30-8:15 am. Cats not benched by end of check in will be marked absent. Judging starts at 9am Saturday & 8:30 am Sunday. Advertised show hours 9am – 3pm both days.

Fly-ins: Raleigh - Durham International Airport (RDU) is about 11 miles/15 minutes from the show hall.

Household Pets: All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

Supplies & Cages: Single cage size is approximately 22"x22"x22" and is included with your entry. Exhibitors with an odd number of entries using any size security cage are required to purchase an extra 1/2 cage. Litter will be provided, litter pans will not be furnished.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition.

Liability: No watchman will be provided during non-show hours. Cats cannot be left in the show hall overnight. Coastal Paws Cat Club will take reasonable care to safeguard the personal property of exhibitors; however, neither the club, its members nor the NC State Fairgrounds will be liable for any loss, damage or injury to exhibitors or to their cats.
