Directions: Traveling both north and south on I-85, take Exit 108 (Sugarloaf Parkway). Turn right onto Sugarloaf Parkway West. Continue straight through the intersection for Satellite Blvd. The Gwinnett Center entrance is on the left. If flying to Atlanta and renting a car, the Gwinnett Center is approximately 1 hour north on I-85, exit 108.

The facility is air-conditioned and has ample free parking. Handicap access allows for rolling carriers into the show hall. This is a NO SMOKING facility.

DIRECTIONS TO HOLIDAY INN:

Southbound: Travel I-85 to Exit 108 (Sugarloaf Parkway). Turn right onto Sugarloaf Pkwy West. Continue straight traveling through the stop light at Satellite Boulevard. Take the very next left into Gwinnett Center. Take an immediate left into the Horizon Bank/Holiday Inn parking lot. <u>Northbound</u>: Travel I-85 to Exit 108 (Sugarloaf Parkway). Follow the exit to the Sugarloaf Pkwy West ramp. Merge onto Sugarloaf Pkwy NW. Continue straight traveling through the stop light at Satellite Boulevard. Take the very next left into Gwinnett Center. Take an immediate left into the Horizon Bank/Holiday Inn parking lot.

DIRECTIONS TO HOMEWOOD SUITES:

Southbound: Travel I-85 to Exit 109 (Old Peachtree/Sugarloaf Parkway). Follow the exit signs to Sugarloaf Parkway. Turn left at the end of the exit ramp onto Sugarloaf Parkway. Take a left onto North Brown Road. The hotel is on the left.

DIRECTIONS TO LA QUINTA INN:

Southbound: Travel I-85 to Exit 107 (Hwy 120). Go to the top of the ramp, turn right at the light (Duluth Hwy/Hwy 120) and travel to Satellite Blvd. Turn left, the hotel will be on left.

Northbound: Travel I-85 to exit 105 (Hwy 316). Stay to the right and take the Boggs Rd exit. Turn left at the light (Boggs Rd) and travel to Satellite Blvd. Turn right, the hotel will be on right.

Exhibitors are urged to have all cats/kittens inoculated against feline panleukopenia, rhinotracheitis, calici viruses, and rabies. It is recommended that cats and kittens be tested and found negative for FELV. All claws (back and front) must be clipped. Kittens under four months of age are not permitted in the Show Hall. Household Pets over the age of 8 (eight) months must be neutered or spayed. Cage size is approx 22x22x22.

CFA RULES WILL BE STRICTLY ENFORCED. Copies of the current Show Rules may be ordered on line at <u>www.cfa.org</u> or by mail from CFA Central Office, 260 East Main Street, Alliance, OH 44601. The cost of \$7.00 (includes shipping/handling) must be included with your order.

All Championship, Premiership, and Registered Kittens will be scored for CFA National and Regional Points. Kitten registration numbers must be printed or written in the Master Catalog in order to be scored. Special prizes and ribbons will be offered in all rings for final awards. Flats will be offered for all other awards in accordance with CFA Show Rules. Declawed cats are ineligible. There will be NO veterinary inspection prior to benching. All cats are expected to be free of fleas, fungus, ear mites, and any contagious diseases.
