Show Hours Check-in 8:00-9:30 a.m. Judging will begin at 10:00 am on Saturday and 9:00 am on Sunday. Cats not checked-in by 9:30 a.m. will be marked absent. The advertised show hours are 10:00 am-4:00 pm Saturday and 9:00 am-4:00 pm Sunday. The show hall is accessible for those with mobility disabilities, heated and air-conditioned. This is a nonsmoking showhall. All Championship, Premiership and Kitten entries will be scored for CFA Regional and National awards. CFA Show Rules will be strictly enforced. All claws of entries must be clipped prior to benching. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies(required in Ohio). Any entry suspected of having a parasite, skin disease or other illness will be removed from the show hall until cleared by a veterinarian. Household Pets must be 4 months old to be entered and if over the age of 8 months must be neutered or spayed. **No kittens under 4 months of age will be allowed in the show hall.** Single cages are approx. 22 x 22 x 22. **Novice Exhibitors:** Let us know if you are new to showing and we can assist you. Please bring cage curtains, grooming aids, your own litter pans and food. People food will be available. Litter will be provided. All cats must be brought to the show hall in some sort of carrier. **Motel:** There are many hotels in the area. Information and directions will be provided with your confirmation.
