Entries sent online must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Empire Cat Club. No substitutions accepted after the closing date. No refunds made once your entry is received. CFA registration numbers must be included for all Championship and Premiership classes. *No end of row fee for handicapped exhibitors.

Show Hall: The Lebanon Valley Expo Center 80 Rocherty Road Lebanon, PA 17042. The show hall is heated /air conditioned and handicapped accessible. Hours: Check-in Saturday 7:30-8:30am. Judging will begin at 9:00am. The show hall WILL NOT be open before check-in time, please do not arrive early. Advertised hours are 9am-4pm.

EXHIBITOR INFORMATION: Litter will be provided but no litter pans -- we remind exhibitors to bring their own. All Championship, Premiership and registered Kitten entries will be scored for CFA National and Regional Awards. All claws of all entries must be clipped prior to benching. No declawed entries are permitted. Cats or Kittens should be clean and free of fungus, fleas, ear mites and any contagious of infectious illness. No kitten under the age of 4 months shall be permitted in the show hall. All cats or kittens for sale must have entry in show and must ensure an enclosed, secured carrier. no exhibitor may leave cats or kittens in theshow hall overnight.
