It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline enteritis, feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested for FeLV before entry. All claws of all entries must be clipped prior to benching. The cage size is 22" x 22" x 22". Litter will be provided but please bring your own litter pans and food. The club reserves the right to add judges not named in the show announcement to judge non-championship and non-premiership classes.
