CHECK IN & SHOW HOURS

Saturday check in: 7:30-8:30 am Any cat not benched by end of check in will be marked absent and must inform the clerk in each ring. Judging will begin at 9 am on Saturday and at 8:30 on Sunday Advertised show hours both days 9 am - 3 pm.

ENTRIES: It is the exhibitor's responsibility to contact the Entry Clerk to confirm receipt of online or fax entries. The Entry Clerk/Club will not be responsible for entries lost due to communication errors. Per show rule 11.08 a.; all entries must be accompanied by proper entry fees. Entries sent online or faxed must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Feline Forum. US\$ Check only; returned check fee \$50 + bank fees. Anyone paying at check-in for ANY reason will be charged an additional \$5 pay-at-the-door fee; the pay-at-the-door fee will be waived for Canadian exhibitors. PayPal payments will be accepted PRIOR TO CLOSING DATE; contact the entry clerk for payment info. No substitutions accepted after the closing date. No refunds made once your entry is received. or for failure to bench. All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number. Use of ANY size security cage with a single will require purchase of an extra ½ cage space. *End of Row will be waived for handicapped exhibitors. SHOW HALL: Bellevue Community Center 510 Duncan Rd. Wilmington, DE 19809. Ph: 302-762-1391. The show hall has heat/AC as needed. Food will be available; NO FOOD WILL BE ALLOWED IN THE SHOW HALL.

BENCHING: Single cage size is approximately 22"x22"x22". Please bring cage curtains or fabric to cover top, sides and back of cages. Litter will be provided; please bring food & water bowls and litter pans. Show Management will take all reasonable care to safeguard the personal property of exhibitors, however neither the club nor the notel will be liable for loss or damage to such property. Feline Forum & Maine Coon Cat Club reserve the right to substitute judges in case of illness or emergency. HOUSEHOLD PETS: All HHPs must be at least 4 months old and may not be declawed; any cat over the age of 8 (eight) months must be neutered or spayed. HEALTH: All entries should be inoculated against Panleukopenia, Rhinotracheitis and the Calici Viruses, and we recommend they be tested for FeLV prior to entering the show hall. All cats must be free of mites, fleas, fungus and any contagious illnesses. All claws (front and back) must be clipped prior to benching. AIRPORT INFO: Philadelphia International Airport is about 20 miles from the show hall.
