ENTRIES: Properly completed entries must be submitted on an official CFA Entry form. The use of the online entry form is interpreted as an official entry in this show. It is the exhibitors responsibility to confirm receipt of online entries with the entry clerk. It is the exhibitors responsibility to check their confirmation and notify the entry clerk prior to show closing of any errors or corrections that need to be made. Make checks payable to Foothills Felines. There will be a \$35.00 fee for returned checks. All fees must be paid in US Funds. Per show rule 11.08a - all online entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. All entries paid at check-in must be in CASH. There will be a \$50.00 late fee for any entries not paid in full by August 15, 2012.

SHOW HOURS: Check-in is 7:30am to 8:30am with judging to begin at 9:00am. Advertised hours are 9:00am to 5:00pm. All exhibitors must remain in the show hall during advertised show hours unless permission is received from the show manager.

BENCHING: Benching requests made at time of entry will be honored whenever possible - remember that this is a request not a requirement. NO REFUNDS FOR FAILURE TO BENCH.

SHOW HALL: Simpsonville Senior Activity Center - 310 West Curtis Street, Simpsonville, SC 29681 - 864.967. 9533. The Show Hall is heated, air conditioned, and handicapped accessible. THIS IS A SMOKE FREE FACILITY.

HOTEL INFO: To come with confirmation.

AIRPORTS: **CLT:** Charlotte/Douglas International, Charlotte, NC - 98 miles North of the show hall.
GSP: Greenville/Spartanburg International, Greenville, SC - 15 miles North of the show hall.

GENERAL INFO: CFA show rules will be strictly enforced. A copy of the rules may be obtained for \$7.00 from CFA, 260 East Main Street, Alliance, OH 44601. All Championship, Premiership, and registered Kittens will be scored for CFA National and Regional Awards. Registration number of cats must be printed in the catalog.

HEALTH: This is a non-vetted show. Cats must be free of fungus, fleas, ear/body mites and contagious diseases. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. Per CFA show rules - Show Management reserves the right to have any cat or kitten showing signs of illness, disease or parasites removed from the show hall. All claws must be clipped prior to benching. De-clawed cats are not eligible for entry.

SUPPLIES, ETC.: Single cage size is 21"x 21"x 21". Double cage size is 45"x 21"x 21". No more than one adult or two kittens per single cage space. Cages must be covered on the back, sides and top. All Security Cages / Exhibitor Supplied Cages will be charged for a double cage space. Litter will be supplied. Please bring your own litter pans, food and water dishes.
