### Show Hall

Show hall facilities are handicapped accessible. Hall is heated or cooled as needed. "People" food is available both days. Smoking is not permitted in the show hall.

### Parking

A \$12.00 two day Parking Pass is available at the exhibitors parking lot across the street from the show hall. The NWSC parking attendant will be selling the passes on Saturday. Street parking is very limited in the area. Public transportation to the show hall is readily available.

### Show Catalog

A copy of the show catalog is included with the first entry. Additional copies can be purchased at the front gate for \$3.00 (while supply lasts).

### Entries and Fees

Each entry must be on a signed CFA entry form or exact facsimile. Use of our On-Line Entry form is recommended. For entry clarification, the entry clerk will call collect. Each mailed entry must be accompanied by the stipulated entry fee. Payment in full for faxed or e-mailed entries received more than 10 days before the opening day of the show is required. For your convenience PayPal is available from our online flyer.

No adult, provisional or miscellaneous entry will be accepted without a proper CFA registration number. It is the responsibility of the exhibitor to enter their cats in the proper color class and color description. Please consult the CFA Show Rules and your cat's registration (blue) slip. Incorrect class/color may result in loss of awards received at this show.

This CFA licensed show is held in accordance with the CFA Show Rules. A copy of the **current Show Rules** may be obtained by sending \$5.00 + \$2.00 S&H to CFA, 260 East Main Street, Alliance, OH 44601.

### Benching Cages

Single cages are 21"x21"x21". Double (full) cages are 21"x21"x44". All benching is on tables rather than trestles. Bring your own cage curtains and top and bottom cover-ups. Litter is provided but please bring your own litter trays and dishes.

### Household Pets

FRCC welcomes owners to enter their household pets in our show. Pets will be judged in all 10 rings over two days. Cat over 8 months of age **MUST** be neutered or spayed. Declawed cats/kittens are not eligible for entry. Household pet exhibitors can contact the entry clerk with questions about entering, grooming and preparing for the show.

### Sales Cages

Sale of kittens/cats in the showhall is prohibited by Colorado state law. No sales cages are available at this show.

### New Exhibitors



New exhibitors can use the **New Bee web site** for helpful information about exhibiting their cats/kittens. Be sure to click the New Bee box on the online entry form to be located near an experienced exhibitor who can help you during the show.

### Booth Space

### Ring Clerks

In order to run an efficient show, we are contracting for chief ring clerks. All clerks will be paid per CFA Show Rules. Please contact the entry clerk or show manager if you are interested.

### Awards

Ribbons and rosettes are awarded according to CFA Show Rules. Permanent ribbons are hung for breed wins. Flat ribbons are available from the ring clerks for exhibitors receiving awards. All championship, premierships and registered kittens are scored for CFA national and regional awards.

### Benching

Non-vetted Show! Any entry found with fleas, ear mites, fungus or signs of illness are not permitted in the Show Hall. Only cats which appear healthy, without evidence of fleas, ear mites or any contagious or infectious illness are eligible for admission into the show room. It is the responsibility of the exhibitor to refrain from bringing an unhealthy cat or kitten into the show hall. Failure to observe this rule is grounds for disciplinary action (2.02a)

Any cat from a house or cattery where there has been feline distemper (panleukopenia) within 21 days of the opening date of the show is ineligible for entry and should entry have been made prior to the onset of any such condition, such entry is ineligible for admission into the show hall.(2.02) It is strongly advised that all cats/kittens entered in the show be inoculated by a licensed veterinarian against feline panleukopenia (formally known as feline distemper or feline infectious enteritis), feline Rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats/kittens be tested for FeLV and found negative before entry.(4.09) Cat's claws must be clipped on all four feet. **DECLAWED CATS/KITTENS ARE INELEGIBLE FOR ENTRY.** ALL claws of each entry must be clipped prior to benching. Failure to do so will subject the entry to disqualification. (4.10)

**No kittens** under 4 months of age are allowed in the show hall per CFA Show Rules.(2.12) CFA litter registration must be present to Show Management upon request or kitten(s) must be removed from the show hall immediately. Colorado State Law prohibits leaving animals in vehicles. **No cats/kittens** can be kept in carriers under the benching tables. **No cats/kittens** not entered in the show are allowed in the Show Hall without Show Manager approval.
