Entry Info: Full payment must accompany all mailed entries. Per Show Rule 11.08a all fax or online entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Properly completed entries must be submitted on an official CFA Entry form or facsimile, sent online, or faxed with all information, except signature typed or hand-printed. The use of the online entry form is interpreted as an official entry in this CFA show, and your email address on the form is considered to be your signature per CFA Show Rule 4.05. Make checks to Freestate Feline Fanciers. PayPal payments must be made before closing date; send to meloncali@comcast.net. Email the Entry Clerk to confirm receipt of online/fax entries; Neither the Entry Clerk nor the club will be responsible for entries lost due to communication errors. It is the responsibility of each owner to enter and to verify that all information contained on the confirmation is correct. Incomplete entry forms will be returned. No substitutions may be made after the closing date. No refunds for failure to bench. Use of Security cages with an odd number of entries will require the purchase of an Extra 1/2 cage. \*End of Row no charge for handicap exhibitors.

**NEW Show Hall: Freestate Sports Arena, 5811 Allender Rd, White Marsh, MD 21162.** 410.335.6400. The show hall is handicap accessible, The facility has no a/c but is kept cool by use of many ceiling fans and large exhaust fans. Parking is free. People food will be available.

CFA Show Rules: All CFA Show rules will be strictly enforced. Show rules are available online <a href="http://cfa.org/client/formsmanuals.aspx">http://cfa.org/client/formsmanuals.aspx</a> or by sending \$7 to CFA 260 E. Main St. Alliance, OH 44601. All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number.

No kitten under the age of 4 months old is permitted in the show hall. Cats may not be confined in carriers. No cats may be left in the show hall overnight. Cages are approximately 22"x22"x22". Exhibitors are advised to bring cage drapes or covers for the top, sides and bottom of the cage. Litter will be available, please bring your own litter pan. Health: This is a non-vetted show. All cats/kittens/Household Pets must be free of fleas, fungus, ear mites and other disease; should be inoculated against feline panleukopenia, rhinotracheitis, calici viruses and rabies; should be tested negative for FeLV; and must have both front and back nails trimmed prior to benching. Declawed cats are not eliqible for entry.

**Liability:** The club reserves the right to add and/or substitute judges not named in the show flyer should it become necessary. The sponsoring clubs will take reasonable care of all cats and personal property, but will not be held liable for loss of property, damage, or accidents to cats or exhibitors.
