Entry & Payment Info: Entries are accepted now. Entry Fees include CFA & Regional surcharges. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Freestate Feline Fanciers. *Returned Check Fee is \$50 (plus all bank fees).* A **Late Fee of \$50 will be added to ANY fees not paid by 10/8/19.** No substitutions will be accepted after the closing date. No refunds made once your entry is received or for failure to bench. **Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE THE CLOSING DATE.**

Show Hall: Exhibition Hall at the Maryland State Fairgrounds 2200 York Rd. Timonium, MD 21093 Ph: 410-252-0200. The show hall is handicapped accessible and air conditioned. People food will be available.

Show Hours: Check in: 7:30-8:30 am on Saturday and 8-8:30 am on Sunday. If you are marked absent please check in with the Clerk in each ring. Judging will start at 9 am both Saturday and Sunday. Advertised show hours are 9 am – 4 pm both Saturday and Sunday.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number. Rosettes will be awarded and permanent flats will be used in accordance with CFA show rules. All show rules will be strictly enforced. Copies of the show rules are available for \$7 from CFA 260 East Main St. Alliance, OH 44601.

Fly-ins: Baltimore/Washington International (BWI) is approximately 35 miles from the show hall and show hotel. Exhibitors are responsible for their own transportation.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped prior to benching. Declawed cats are not eligible for competition.

Household Pets: All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

CFA Agility Competition: Cats will run the agility course at both shows (you must enter each show separately). For more info please go to agility.cfa.org/index.shtml.

Benching: Individual cage size is 22" X 22" X 22" and is included with your entry. **Single entry with ANY size security cage requires the purchase of an extra 1/2 cage.** Bring your own litter pans. Club will provide litter.
