SHOW HOURS:

Check-in time is 7:30-8:30. Show will begin at 9:00am. Advertised hours are 9:00am – 3:00 (Finals). All benched entries will be expected to remain in the show hall until advertised closing time, unless permission is given by Show Manager

No veterinarian inspection prior to benching will be required. You are advised to have your cats inoculated against feline enteritis, Feline Rhinotracheitis/Pneumonitis, Calici Viruses, and tested negative FELV for entry. All cats must be free of fungus, ear mites, parasites, and all the above. The show committee reserves the right to remove any cat from the show hall until a licensed veterinarian can pass on all cats. All cats must have their nails clipped prior to benching. According to CFA rules no declawed cats are shown. Reasonable care will be taken of cats and personal property. Neither Frontier Feline Fanciers, Cats KC nor Topeka Cat Fanciers nor its individual members shall be liable for property lost or damaged. Johnson County Fairgrounds will not be liable for any loss or damage. *Smoking is outside*

All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or TRN will not be included in the count. The club reserves the right to add judges not named to judge. Kittens under 4 months of age will not be allowed in the showhall.
