No veterinarian inspection prior to benching will be required. Exhibitors can check in Friday evening from 5-7 PM and Saturday morning from 8 until 9:15 AM. JUDGING WILL START **PROMPTLY** at 9:30 AM ON SATURDAY AND 9:00 AM ON SUNDAY. Closing will be approximately 5 PM on Saturday and 4 PM on Sunday and all exhibitors, except kittens, are required to stay until this time unless permission to leave is received from the Show Manager. Our show is held under the auspices of the Cat Fanciers Association. CFA show rules will be strictly enforced. A copy of the rules is available for \$5.00 from CFA, 1805 Atlantic Ave. PO Box 1005, Manasquan, NJ 08736-1005. The club has the right to add judges not named in the show announcement to judge non-championship and non-premiership classes. All championship, premiership and registered kittens will be scored for CFA National and Regional awards. All exhibitors are strongly advised to have cats and kittens inoculated by a licensed vet against enteritis, feline rhinotracheitis, calici virus and rabies and tested for Fel V before entry. Claws must be clipped front and back. No kittens under 4 months of age will be permitted in the show hall. NO cats can be declawed. All entries must be submitted on the official CFA entry blank accompanied by the proper fees. CFA registration numbers MUST be included for all Championship, Premiership, A.O.V. cats and kittens as well as Provisional Breeds. Make checks payable to GARDEN STATE CAT CLUB. A fee of \$25.00 will be charged for any checks returned by the bank. All checks MUST be drawn on U.S. banks or paid in U.S. funds. We will honor a maximum of two benching requests or one agent request. Litter will be provided but not trays. Bring your own cat food and water dish. No watchman will be provided during the hour the show is not open and NO CATS may remain in the showhall overnight. Cages are approximately 22"x 22"x22". Cage curtains or coverings are required.

Our show hotel, **the HOLIDAY INN, Somerset (732) 356-1700**, the show rate is \$ 89.00. MAKE YOUR RESERVATIONS BY 6/22/07. Our show hall is AIR CONDITIONED. Smoking is NOT permitted in the benching areas. Detailed directions and hotel information will be sent with the confirmation.
