Discount spectator coupons at www.GardenStateCatClub.com Check in is from 5 - 7 PM on Friday and 7:30 - 9:00 on Saturday. Any cat not benched by 9:00 will be marked absent. Judging will begin at 9:30 AM (SHARP) on Saturday and 9:00 AM on Sunday. Advertised hours are 10:00 to 5:00 on Saturday and 9:30 to 4:00 on Sunday. Cage size is approximately 22"x22"x22" Please inform the entry clerk if you have your own security cage. Litter will be provided, but not litter pans. All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number. All claws of all entries must be clipped prior to benching. This is a non-vetted show, and all entries are expected to be inoculated against feline panleucopenia, rhinotracheitis, calici viruses and rabies and to be tested negative for FeLV before entry. Copies of CFA show rules may be obtained for \$7.00 each from CFA, 260 E. Main St. Alliance, OH 44601.
