Entries submitted in the final 10 days before the show date must pay at check-in and must pay in cash. NO REFUNDS/CANCELLATIONS after confirmation has been issued. Collect Calls will be made in the event of entry errors or omissions. Exhibitors with security cages must purchase double cage spaces. NO CAGES ON MARKED GROOMING SPACES! All championship, premiership, kitten & HHP entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number (TRN). This is a CFA licensed show and all CFA show rules will be enforced. For a copy of the show rules, send \$7.00 to CFA, 260 East Main St, Alliance, OH 44601 (330-680-4070). The club reserves the right to add judges not named in the flyer. Cage size is 21"x21"x21". Litter will be available; bring your own litter pans, cat food, and dishes. Claws of all entries must be clipped prior to benching. It is strongly advised that all cats and kittens present in the show hall be inoculated against feline enteritis, rhinotracheitis, calici virus, and rabies It is further recommended that cats and kittens be found negative for FeIV before entry. All entries must be free of fleas, fungus, and infectious diseases. Declawed cats are not permitted in the show hall. No kittens under the age of 4 months will be permitted in the show hall. Show hall is heated and air conditioned. The club will not be responsible for lost or stolen articles. SALES CAGES: There will be a limit of one double sales cage per exhibitor. To have a sales cage you must have at least one CFA registered entry in the show. Kittens must be at least four months old. CFA litter registrations will be required by show management. There is a maximum of two kittens or one cat per single (1/2) cage. All sales animals must be in cages. Absolutley no cats or kittens will be allowed in carriers under the tables.
