**Entry Info:** It is the exhibitor's responsibility to contact the Entry Clerk to confirm receipt of online or fax entries. Neither the Entry Clerk or Club will be responsible for entries lost due to communication errors. Check entry confirmation and notify entry clerk of any errors. Per show rule 6.21; all entries *must* be accompanied by proper entry fees. Entries sent online or faxed *must* be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Hidden Peak. *Sorry, No PayPal.* No substitutions after the closing date. No refunds made once your entry is received or for failure to bench. All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number.

**Show Hall:** Maryland State Fairgrounds 2200 York Rd. Timonium, MD 21093 Ph: 410-252-0200. The show hall is handicapped accessible and air conditioned (Use the North Gate Entrance on York Rd).

**Cages:** Individual cage size is 22" X 22" X 22". **Single entry with ANY size security cage requires the purchase of an extra 1/2 cage.** Bring your own litter pans. Club will provide litter. Sales cage is available with paid entries.

**Awards:** Rosettes will be awarded and permanent flats will be used in accordance with CFA show rules. All show rules will be strictly enforced. Copies of the show rules are available for \$7 from CFA 260 East Main St. Alliance, OH 44601.

**Household Pets:** All Household Pets over the age of 8 (eight) months must be neutered or spayed and may not be declawed.

**Health:** All entries should be inoculated against Panleukopenia, Rhinotracheitis and the Calici Viruses, and we recommend that they be tested for FeLV prior to entering the show hall. All cats must be free of mites, fleas, fungus & any contagious illnesses. All claws (front and back) must be clipped prior to benching.
