GENERAL: Show will be conducted under CFA Show Rules and will be enforced. For a copy of Show Rules, contact CFA, INC., 260 East Main Street, Alliance OH 44601. Telephone 330/680-4070. All cats must be registered with CFA except Kittens and Household Pets. Non-vetted show. All cats and kittens should be vaccinated against feline enteritis, feline rhinotracheitis, calici virus, rabies and tested for feline leukemia. Cats must be free of fleas, fungus, ear mites or any contagious illness. All claws must be clipped. Declawed cats may not be entered. Single cage is approximately 21"x21"x21".

FEES: All fees (US funds) must be paid no later than 10 days from the date of the show. Make checks payable to **Illinois Feline Fanciers, Inc.** There will be a \$75.00 fee for returned checks. Exhibitors are required to pay entry fees for any entry received by E-mail. Included are double cage fees, extra entries required for a security cage or other special requests. No refunds for failure to bench.

CONFIRMATION: Legibly print or type all information. All entries will be acknowledged. Entry Clerk may call collect to verify questionable entries. All entries must be received by 6:00 p.m., October 13, 2015. Please notify Entry Clerk of any errors.

AWARDS: Ribbons and rosettes will be awarded according to CFA Show Rules. Permanent ribbons will be used where permitted, fabric ribbons will be available. Championship, Premiership and Registered Kittens whose registration numbers are printed in the show catalog will be scored for CFA Regional and National Awards.

SALES: Exhibitor must complete a kitten sales sheet available at the Master Clerk table and provide attached sheet to purchaser. Forms are used to allow sales in the Show Hall. Noncompliance will be grounds for removal from show hall and future denial of entries.

SHOW HALL: Building has heat and air conditioning and is wheelchair accessible. Lunch bar and snacks will be available. Coolers are permitted. Show management is not responsible for loss or damage. **NO SMOKING** in the show hall or Illinois Building.

VENDOR SPACE: Contact Norma Jean Bromwell at 217/546-8370. Tables are 6 feet in length. No personal folding tables permitted.

CAT SUPPLIES: Litter will be furnished. Bring your own food and litter pans.

HOUSEHOLD PETS: Limited to kittens ages 4 – 8 months and neutered or spayed adult cats. They are judged without regard to age or sex. Entry fees apply to HHPs regardless of age and will be judged both days. Declawed cats may not be entered.
