**Entries:** All entry fees include \$2 CFA Surcharge. There are no additional fees for online/fax or substitutions. Email Entry Clerk to confirm receipt of online/fax entries, the Club is not responsible for entries NOT received due to communication errors. Per show rule 11.08 a.; entries *must* be accompanied by the stipulated entry fee. Online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. **Make checks payable to Just Cat-In Around Cat Fanciers;** returned check fee is \$50. No substitutions after closing date and no refunds after the entry clerk has confirmed your entry **SINGLE ENTRIES WITH ANY SIZE SECURITY CAGE MUST PURCHASE AN EXTRA ½ CAGE SPACE. CASH ONLY AT CHECK-IN. Club rates are given to those who work set-up.**

**SHOW HOURS:** Check in 8:00-8:45 am. Any cat not checked in by 8:45 will be marked absent. Judging will begin promptly at 9:00 am both Saturday and Sunday. Advertised show hours are 9:00 am to 4:30 pm both days. Note: Toledo Express Airport is 10 miles from the show hall.

**SHOW HALL:** Hall #2 @ the Lucas County Recreation Center, 2901 Key St. Maumee, OH 43537 Phone: 419-893-2127. The show hall is heated. Smoking is allowed outside. Show hall is wheelchair accessible. People food will be available.

**SHOW RULES:** This show will be conducted under current CFA rules. A copy of the rules may be obtained by sending \$7.00 to CFA 260 East Main St. Alliance, OH 44601. All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number. It is advised that all entries be tested for FELV, and be inoculated by a licensed veterinarian against Feline Panleukopenia, Rhinotracheitis, Calici Virus and Rabies before entry. Claws of all four feet must be clipped prior to benching. No declawed cats may entered. All cats must be free of fleas, fungus earmites, and any contagious illness. Show Management reserves the right to cause the removal of any cat from the show hall of any of the above until a licensed veterinarian can make an examination at the exhibitor's expense.

**SALES CAGES:** To have a sales cage you must have at least one CFA registered entry in the show. Kittens must be at least four months old. CFA litter registrations will be required by show management. There is a maximum of two kittens or one cat per single cage. All sales animals must be in a cage. Positively no cats or kittens will be allowed in carriers under the tables.

**CAGES:** A single cage measures 21" x 21" x 21", a double cage measures 21" x 21" x 42". Bring your own litter pans and food; litter will be provided.

**LIABILITY:** Neither the clubs, its members or the Fairgrounds will be liable for any loss or damage. No guard service will be available Saturday evening and all cats must be removed from the show hall during the evening.
