**HOTEL:** "This is a Hotel Show" Alexis Park Resort, 375 E. Harmon Avenue, Las Vegas, Nevada. Call (702)796-3322 or 528-2228 for reservations, please reference "**CFA**" for the \$89.00 (plus taxes) rate per night. Please note there is no resort fee or PET DEPOSIT. Reservations must be made by December 1, 2009 to receive the \$89.00 rate, cancellations must be made forty eight (48) hours before arrival day. We want to be invited back, please keep your room the same as you found it. If we are notified of a less than acceptable room by the Alexis Park, we will assess a penalty of \$100.00.

**SHOWHALL** is in Alexis Park Resort Ballroom. The show hall is heated and air conditioned. Showhall and resort are handicapped accessible. Smoking is NOT permitted in the showhall. NO OUTSIDE FOOD IS PERMITTED IN THE SHOWHALL. Food will be available for purchase from the Alexis Park Hotel (please mention CFA when ordering). Crown City Cat Club, Catalina Cat Club and the Alexis Park Hotel are not responsible for damage, loss, personal injury or loss of personal property. No cats may be left overnight in the showhall. Vending is not allowed from cage or grooming space.

**AIRPORT and TRANSPORTATION:** McCarran Airport is 1.9 miles from the showhall. Alexis Park and Bell Transportation have arrangements to and from the airport; the rate is \$6.00 each way. To arrange your reservation, call (800) 274-7433, you will be picked up outside of door 9. Taxi's are always available and under \$10.00.

**SHOW HOURS:** Check-in Saturday will be from 8:30 to 9:30 AM. Judging will begin 10 AM Saturday and 9 AM Sunday. Advertised show hours are 10 AM to 5 AM both days. No entries, with the exception of kittens, may leave the showhall before the end of advertised show hours without permission

**ENTRY INFORMATION:** Entries for Championship, Premiership, AOV, Provisional and miscellaneous classes must have a registration number on the entry form and printed in the catalog. Kittens must be (4) months of age or older on the opening day of the show. You may enter by email, snail mail or fax; *all mailed entries must be submitted on an official CFA entry form.* You may enter online on the Southwest Region's website [www.cfasouthwest.org](http://www.cfasouthwest.org) or [www.catshows.us](http://www.catshows.us).

**Per CFA show rules, fees for entries submitted electronically must be made within TEN DAYS or at check-in, whichever comes first.** Make checks payable to *Crown City Cat Club*. Returned check fee is \$50.00. It is the exhibitors' responsibility to verify received entries before the published closing date

**BENCHING:** Single cage is 24"w x 24"d x 24"h. Double cages are 48"w x 24"d x 24"h. All Security Cages *require* Double Cage Space. Only one cat or two kittens per cage. A breeder who has For Sale Only and/or Exhibition Only kittens/cats *must* have a kitten/cat entered in competition. Benching requests will be honored whenever possible (1 request per agent/exhibitor). Please, no negative benching. Benching changes will be made only with permission of a show manager.

**HEALTH:** This is a non-vetted show. All kittens and cats entered should be inoculated against feline Enteritis, Rhinotracheitis, Calici Virus and test negative for FeLV. Entries must be found free of fungus and parasites and contagious or infectious illness. Any cats suspected of being ill or having any of the above mentioned (but not limited to), is subject to removal from the showhall in accordance with CFA show rules. All claws must be clipped prior to benching.

**AWARDS:** Rosettes will be awarded in accordance with CFA show rules. All Championship, Premiership and registered Kittens entered will be scored for CFA National and Regional points. Current CFA show rules may be obtained for \$5.00 from CFA, P.O. Box 1005, Manasquan, New Jersey 08736.

**AMENITIES:** Litter will be provided. Please bring your own litter trays, food and dishes.
