Benching is 7:30 AM to 8:30 AM with judging to begin at 9 AM sharp. All cats must be checked in by 8:30 AM or they will be marked absent. The advertised show hours are 9:00 AM to 5:00 PM. One benching request per exhibitor will be honored if possible. Handicap benching requests will be honored if possible.

No veterinarian inspection prior to benching is required. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline enteritis, feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested for FeLV before entry. All claws of all entries must be clipped prior to benching.

Show Hall: Sportsplex, 13333 Telegraph Rd. Taylor, MI 48180 Phone: 734-374-5838. The show hall is heated/air conditioned as needed. This is a NON-SMOKING show hall. A detailed map to the show hall and hotel information will be sent with your confirmation.
