Entry Info: No additional fees for fax or online entries. *All entry fees include CFA surcharges*. Per show rule 6.21 each entry *must* be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. It is the exhibitor's responsibility to confirm receipt of online/faxed entries with the Entry Clerk. The club will not be responsible for entries lost due to communication errors. *Make checks payable to Midwest Persian Tabby Fanciers*, all funds must be in US funds. ALL fees paid at the door must be in CASH. No credit cards. No refunds once your entry has been received or for failure to bench. *Single entry with ANY size security cage requires the purchase an extra ½ cage space*. Club member rates for working members whose entries are received no later than to January 17, 2016.

**Show Hall:** Monroe County Community College – Gerald Welch Health Education Building - 1555 S Raisinville Road, Monroe, MI 48161 Phone: 734-384-4240. The show hall is handicapped accessible and heated.

**Check-in:** 7:30-8:30 am Saturday, any cat not benched by 8:30 will be marked absent. Please report any transfers or absentees at check-in. Judging will begin at 9:00 am both days. All adult entries must remain in the show hall during advertised hours of 9 am – 4 pm (or until completion of judging).

**Local Airport Info:** Detroit Metro Airport (DTW) is about 33 miles from the show hall. Toledo Express Airport (TOL) is about 20 miles from the show hall.

**Household Pets:** All Household Pets over the age of 8 (eight) months must be neutered or spayed. Entries of any age must not be declawed.

**Additional Info:** Cage size is approximately 22"x22"x22", bring cage curtains (or coverings) to cover the sides, top and bottom of cage. New exhibitors are advised to bring cage drapes or towels, etc. for the floor, sides and top of the cage. Please advise the entry clerk if this is your first show. All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number. No declawed entries are permitted and all entry's front and rear claws must be clipped prior to benching. No kittens under 4 months are permitted in the show hall or on the show grounds. No cats or kittens may be left in the show hall overnight. Only benched cats and kittens are permitted in the show hall, none may be confined in carriers. This is a non-vetted show, and all entries are expected to be inoculated against: Feline Panleukopenia, Rhinotracheitis, Calici virus and rabies and to be tested negative for FeLV. The exhibitor of any entry showing evidence of fungus, fleas, ear mites or any contagious disease will be asked to remove that entry as well as their other entries from the show hall. By entering exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA show rules. CFA show rules may be obtained for \$7.00 each from CFA, 260 E. Main St. Alliance, OH 44601. *Midwest Persian Tabby Fanciers reserves the right to substitute judges in case of illness or emergency.*
