SHOW HOURS: Check-in -Sat. & Sunday 7:30 a.m. – 8:30 a.m. - Show Hours: Sat 9:00 AM. – 5:00 PM. Sun 9AM to 5:00PM. All entries are expected to remain in the show hall until the advertised closing time. Early departure without permission of the show manager will result in all wins being voided. Kittens and HHPs are exempt from this rule.

SHOW HALL: Hampton Inn & Suites Convention Exhibit Hall B is handicapped accessible and heated & air conditioned. Smoking in not permitted in the show hall. The concession stand will have a selection of food for your enjoyment. CAKES are permitted with approval from Show Manager.
