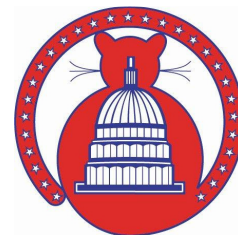

Show Hall: Dulles Expo Center 4320 Chantilly Shopping Center, Chantilly, VA 20153 (Rt. 28 at Willard Road) Ph: 703-378-0910. The show hall is air conditioned and wheelchair accessible. People food is provided and there is plenty of free parking. This is a non-smoking facility.
Check In & Show Hours: Friday evening from 5 to 7 pm and Saturday from 7:30 - 9:00 am. Judging will start at 9:30 am Saturday; 9 am Sunday. Advertised show hours are 9:30 am - 5 pm Saturday; 9 am - 4 pm Sunday. No entries, with the exception of kittens, may leave the show hall before the end of the advertised show hours without the permission of the Show Manager.
Entry Info: It is the exhibitor's responsibility to contact the Entry Clerk to confirm receipt of online/fax entries. Neither the Entry Clerk or Club will be responsible for entries lost due to communication errors. Per show rule 6.21; all entries *must* be accompanied by proper entry fees. Entries sent online or faxed *must* be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to National Capital Cat Show. Make PayPal payments to natcap-entry@outlook.com. No substitutions will be accepted after the closing date. No refunds made once your entry is received or for failure to bench. **Exhibitors with odd numbered entries using ANY size security cage requires the purchase of an extra ½ cage.**
Awards: Rosettes will be awarded and permanent flats will be used in accordance with CFA show rules. All show rules will be strictly enforced. Copies of the show rules are available for \$7 from CFA 260 East Main St. Alliance, OH 44601. All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number.
Supplies: Bring your own litter pans. Club will provide litter. Individual cage size is 22" X 22" X 22".
Hotel Info: There is no official show hotel but the Holiday Inn Chantilly/Dulles Expo is closest to show hall (across the parking lot). 4335 Chantilly Shopping Center, Chantilly, VA 20151 Ph: 703-815-6060. The hotel has a free airport shuttle. There are numerous hotels in the area best way to research is to go to www.hotels.com Chantilly and select Pet Friendly. Fly-ins: Dulles International Airport (**IAD**) is a 15-20 minute drive. Reagan National Airport (**DCA**) is a 45-60 minute drive. Baltimore Washington International Airport (**BWI**) is about 1 1/2-2 hours away.
Health: All entries should be inoculated against Panleukopenia, Rhinotracheitis and the Calici Viruses, and we recommend that they be tested for FeLV prior to entering the show hall. All cats must be free of mites, fleas, fungus and any contagious illnesses. All claws (front and back) must be clipped prior to benching.
Household Pets: All Household Pets over the age of 8 (eight) months must be neutered or spayed and may not be declawed.
Cats & Kittens For Sale: Sales cages will be available only if you have an entry in the show. Please keep in mind the show rule which limits two kittens per single cage. No kitten under 4 months of age is permitted in the show hall. A Rabies certificate is required by **Virginia state law** for all kittens that are 4 months of age.
