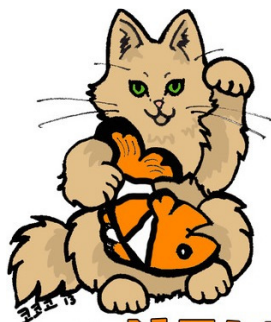

Entries: Entry fees include CFA/Regional surcharges. No additional fees for online/faxed entries. It is the exhibitor's responsibility to confirm receipt of online/fax entries with the Entry Clerk; the club will not be responsible for entries lost due to communication errors. Mailed entries must be typed or printed legibly, signed and submitted on an official CFA entry form. Fees MUST accompany the entry form. All entry fees are due within 10 days of entry per CFA show rules. Make checks payable to New England Meow Outfit; Returned Check Fee \$50. Send PayPal to nemocatclub@yahoo.com PRIOR TO CLOSING DATE. No refunds for failure to bench. Sales cage must accompany a paid entry. Use of ANY size security cage with odd numbered entries requires the purchase of an extra 1/2 cage space. Benching requests made at the time of entry will be honored when possible.

Show Hall: Our show hall is AC/heat available as needed and handicapped accessible. No outside food/drink allowed. Clay litter will be provided. Please bring your own litter pans, cat food, and water/food dishes.

Hours: Check-In: Saturday 8:30 - 9:30 am. **Judging will start at 10 am on Saturday** and at 9 am on Sunday. **Advertised hours:** Sat. 11 am - 5 pm & Sun 9 am - 4 pm.

Show Hotel: [Sturbridge Host on Cedar Lake](http://SturbridgeHost.com) 366 Main St. Sturbridge, MA 01566 Phone: 508-347-7393. \$97 single or double, \$102 triple, \$116 quad **if reserved by August 1, 2014.** There will be a one time non-refundable pet fee of \$25 for one night for all rooms that will have pets in them; additional nights are \$10 per night. The Sturbridge Host has a AAA three-star rating with restaurants, an indoor pool and Jacuzzi, fitness center, and free Wi-Fi in all guest rooms. Contact the hotel directly for reservations; use code word NEMO for show rate.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. Declawed cats are not eligible for competition.

General: Cages are 22"W x 22"H x 22"D. CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$7 from CFA, 260 E. Main St. Alliance, OH 44601. All cats/kittens must have all claws clipped prior to benching. All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number.

NEMO reserves the right to substitute judges in case of illness or emergency.
