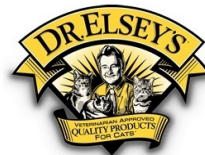

Entry/Payment Info: It is the exhibitor's responsibility to confirm receipt of online entries with the Entry Clerk; the club will not be responsible for entries lost due to communication errors. Mailed entries must be typed or printed legibly, signed and submitted on an official CFA entry form and ALL entry fees MUST accompany the entry form. All entry fees are due within 10 days of entry per CFA show rule 6.21. Paid entries will be entered before online entries. Make checks payable to National Norwegian Forest Cat Breed Club, Inc. US checks only. **CLUB DOES NOT ACCEPT PAYPAL. Payment at the door must be in CASH.** No refunds once your entry has been received or for failure to bench. *Sales cage must accompany a paid entry. EOR with a single entry must purchase an extra ½ cage space. Use of ANY size security cage with a single entry requires the purchase of an extra ½ cage space. One benching request made at the time of entry will be honored when possible.

Hours: Check-In: Saturday 7:30-8:30am **Judging will begin at 9am Saturday and 8:30am on Sunday.** Advertised show hours: 9am – 4pm both days.

Show Hall: Rollway Skating Rink, 131 South Second Rd. Hammonton, NJ 08037 Ph: 609-561-8061. The Show Hall is heated, air conditioned, and handicapped accessible. People food on site for breakfast, lunch, etc.

Hotel Info: There is no official show hotel; Google "pet-friendly hotels, Hammonton or Atlantic City, NJ".

Fly-Ins: Philadelphia International or Atlantic City Airports.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. **New Jersey law requires all cats to have proof of rabies available at the show.**

Scoring: CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$7 from CFA, 260 E. Main St. Alliance, OH 44601. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition. All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or TRN will not be included in the count.

Benching: All benching will be by exhibitor and no changes in assignment will be allowed without permission of the Show Manager. Cages are 22"W x 22"H x 22"D. Clay litter will be provided. Please bring your own litter pans, cat food, and water/food dishes.
