#### ADVERTISED SHOW HOURS

9:00 a.m. to 5:00 p.m. All adult entries must remain in the show hall until 5:00 pm

Entries: All entry fees include the CFA \$2 surcharge. Per show rule 11.08 a.; all entries *must* be accompanied by proper entry fees. Entries sent online or faxed *must* be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Nutmeg Cat Fanciers, all checks must be in U\$ and all payments made at check-in MUST be in CASH. There is a \$5 pay at the door fee, no matter the reason (Canadian exhibitors are exempt). No substitutions accepted after the closing date. No refunds made once your entry is received. CFA registration numbers must be included for all Championship and Premiership classes. Cage size is approximately 22"x22"x22". Any size security cage must purchase a double cage space. Bring cage curtains (or coverings) to cover the sides, top and bottom of cage. New exhibitors are advised to bring cage drapes or towels, etc. for the floor, sides and top of the cage. Please advise the entry clerk if this is your first show. Litter for the show will be provided by Dr. Elsey's <a href="https://www.preciouscat.com">www.preciouscat.com</a> Please bring your own litter pans.

Household Pets: All Household Pets must be over the age of 8 (eight) months must be neutered or spayed and may not be declawed.

Additional Info: All championship, premiership and kitten entries with registration numbers will be scored for CFA National and Regional points. No declawed entries are permitted and all entry's front and rear claws must be clipped prior to benching. No kittens under 4 months are permitted in the show hall or on the show grounds. No cats or kittens may be left in the show hall overnight. Only benched cats and kittens are permitted in the show hall, none may be confined in carriers. This is a non-vetted show, and all entries are expected to be inoculated against feline enteritis, Rhinotracheitis, Calici virus and rabies and to be tested negative for FeLV. The exhibitor of any entry showing evidence of fungus, fleas, ear mites or

Rhinotracheitis, Calici virus and rabies and to be tested negative for FeLV. The exhibitor of any entry showing evidence of fungus, fleas, ear mites of any contagious disease will be asked to remove that entry as well as their other entries from the show hall. By entering exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA show rules.
