BENCHING: This is a non-vetted show. Cats are expected to be free of fungus, fleas and infectious disease. Exhibitors are advised to have their cats vaccinated against feline enteritis, rhinotracheitis, calici viruses, rabies and tested for FeLV prior to entry. All claws must be clipped. Kittens under 4 months of age are not permitted in the show hall. No cats or kittens may be confined in carriers either displayed or under cages. Cage size 22x22x22 inches. Please indicate on Entry Form if you have a security cage. **Single entry with ANY size security cage must purchase an extra ½ cage space.** Litter will be provided. Bring your own litter pans.

CFA INFO: All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number. This is a CFA licensed show; and all CFA rules will be strictly enforced.
