SHOW HALL and DIRECTIONS: Cleburne Conference Center, 1501 W. Henderson St., Cleburne TX 76033, 817-556-8860.

**FROM THE NORTH (FORT WORTH/OKLAHOMA)** on Interstate 35W, take exit 26A (US 67, Dallas/Cleburne) and head west (right). Take the Business US 67 exit (which is East Henderson St) off US 67. East Henderson divides into 2 one-way streets around the Johnson County Courthouse and other downtown buildings. Stay on East Henderson. When the 2 one-way streets merge, you will be on West Henderson. The Cleburne Conference Center is on the left, several blocks past the high school and stadium.

**FROM I-35 SOUTH (AUSTIN/SAN ANTONIO):** Take the I-35 West split just north of Hillsboro. Take Exit 315 towards FM 916/Grandview/Maypearl. Take a left onto FM 916/FM-4/E. Criner Street for 14.2 miles, continuing to follow FM 4. Take a right onto TX 174 N/TX 171N/S Caddo St./FM 4N for 0.6 miles. Take a left onto East Henderson/US 67 BR S for 1.4 miles, which becomes W. Henderson. Cleburne Conference Center is just past S. Ridgeway Drive.

The Chisholm Trail Parkway is now open, connecting Interstate 30 near downtown Fort Worth and Interstate 20 in southwest Fort Worth to Cleburne. For more info: www.ntta.org

**LITTER**: will be provided; please bring litter pans, cat food and cage curtains. For those things you failed to pack: Within walking distance are a Tractor Supply store, Kroger's and Walmart.

**PEOPLE STUFF**: There will be <u>no</u> concession stand. You may bring your own food. Fast-food places are within 1-2 blocks of the show hall.

SCORING and AWARDS: Championship, premiership and registered kitten entries will be scored for CFA national and regional awards. Ribbons and rosettes will be awarded according to CFA rules. This show is licensed by The Cat Fanciers' Association Inc., and its show rules will be strictly enforced. A copy of CFA's show rules can be obtained for \$9 from CFA, 260 E. Main St., Alliance OH 44601, or at www.cfa.org/client/formsmanuals.aspx . All championship, premiership, provisional, miscellaneous and AOV entries must be entered with a CFA registration number. Owners of novices can contact the entry clerk for a temporary registration number.

There will be no veterinarian inspection before benching. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline enteritis, feline rhinotracheitis, calici viruses and rabies. Please bring proof of rabies vaccination. It is also recommended that cats and kittens be tested and found negative of FeLV before entry. All cats/kittens must be free of parasites, fungus and contagious diseases.

<u>All</u> claws of all entries must be clipped prior to benching. Declawed kittens/cats cannot be shown under CFA rules.

Only exhibitors may sell cats or kittens at the show. Agents without an entry may not sell cats or kittens.

**CAGES** are 21 X 21 X 21 single or 21 X 21 X 45 double. Cage sizes may vary. Cages must be covered on the bottom, back, sides and top.

**REASONABLE CARE WILL BE TAKEN OF ALL ENTRIES, MERCHANDISE AND PERSONAL ITEMS.** However, neither Ozark Cat Fanciers, the Cleburne Conference Center, City of Cleburne or the Cleburne Chamber of Commerce will be liable for items lost, damaged or stolen.
