

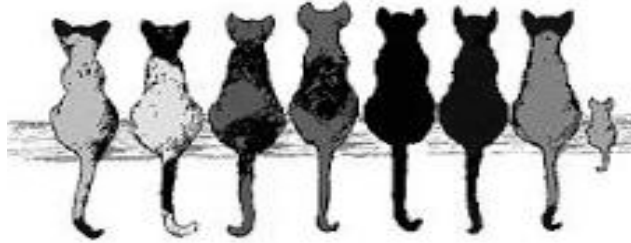

**Show Hall:** The show hall is McClellan Convention Center, 5411 Luce Avenue North Highlands, CA 95652. The hall is air conditioned/heated. The show hall is NO SMOKING. The Lion's Gate Hotel and Conference Center, Northwest Region, Poppy State Cat Club and club members will not be responsible for any personal injury, loss or damage to personal property. **No food is allowed in the show hall.** Lions Gate will have a concession for food and drinks. The club has been given permission to have our morning coffee and donuts available.

***Very Important: NO OUTSIDE FOOD IS ALLOWED IN THE SHOW HALL. Lions Gate will have a concession with sandwiches, salads and drinks available. Please follow these rules so we do not lose our show hall. Lions Gate personnel will be walking through the hall during the day.***

**Check-In:** Check-in 8:00 - 9:30 am, judging begins at 10:00 am. Advertised show hours are from 10 am to 5 pm.

**Cages:** Single cages are 21" x 21" x 21" and are provided with each entry. Double cages are 21" x 45" x 21". If you wish a double cage for a single entry, you must pay the additional cage fee of \$20.00. Single entry with security cage requires a double space unless it is noted that it is a single security cage. No more than two (2) kittens or one (1) adult may be benched in a single cage. The bottom, top, and three (3) sides must be covered.

**General:** This is a non vetted show, but all entries should be inoculated against Feline Panleukopenia, Calici virus and Rhinotracheitis before entry. All claws MUST be clipped prior to benching. No kittens under 4 months are allowed in the show hall. Household Pets over 8 months of age must be spayed/neutered. Declawed cats are not eligible for entry.

**Litter:** Litter will be provided provided. Bring your own litter pan, food/water bowls, and cat food.

**Awards:** Ribbons and rosettes will be awarded for all finals in compliance with CFA Show Rules. All Championship, Premiership, and registered kittens will be scored for national and regional awards. You may obtain a copy of the rules for \$7.00 (U.S. funds) by writing to the Cat Fanciers' Association, 260 East Main St Alliance OH 44601. **Directions:** From I-80 take the Watt Avenue/Northbound. Left onto Palm Ave (into McClellan Park) to Luce Avenue. Look for the big multi-colored building at the end. Free parking.

**Airport:** Sacramento International Airport – 15 miles from show hall and show hotel.

**Show Hotel:** Lions Gate Hotel and Conference Center at 3410 Westover St. Sacramento CA 95652. Phone (916) 640-0801. Queen Standard or Double Deluxe - \$89.00. There is a \$20 non-refundable pet deposit. CUT OFF DATE FOR RESERVATIONS is July 18, 2014. Please mention Poppy State Cat Club when making reservations. The Hotel offers a free hot breakfast buffet and good food in their dining area. The show hall is about 2 blocks from the hotel.

Best Western Roseville Inn at 220 Harding Blvd Roseville CA 95678. Phone (916) 782-4434. Queen Standard or Double Deluxe - \$65.99. There is a \$10 per night pet fee. Please mention Poppy State Cat Club when making reservations .

La Quinta Inn Sacramento North at 4604 Madison Ave, Sacramento, CA 95841. Phone (916) 348-0900. \$65 King or Double deluxe. No pet deposit.

**Fees:** Please make checks payable (in U.S. funds) to **Poppy State Cat Club**. There will be a \$50 fee for returned checks, for ANY reason. **Per show rule 11.08 a. each entry must be accompanied by the stipulated entry fee except e-mailed entries. Email entries MUST be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. All fees must accompany entries. Entry fees will not be refunded for failure to bench.**

**Misc:** Any entry in Championship, Premiership, Provisional or AOV classes must be submitted with a CFA registration number. The entry clerk will call collect if entry information is illegible or incomplete.
