Show Hours Check-in: 7:30 – 8:45AM Judging will begin at 9:00AM. Cats not checked-in by 8:45AM will be marked absent. The advertised show hours are 9AM-4PM.

The show hall is accessible for those with mobility disabilities, heated and air-conditioned. This is a **nonsmoking** hall. All Championship, Premiership and *registered* Kitten entries will be scored for CFA Regional and National awards. CFA Show Rules will be strictly enforced.

IMPORTANT: All claws of all entries must be clipped prior to benching. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia(formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies (required in Ohio). It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. This is a non-vetted show.

Household Pet entries must be 4 months old to be entered and if over the age of 8 months must be neutered or spayed. No declawed cats are permitted. No kittens under 4 months of age will be allowed in the show hall. Single cages are approx. 22 x 22 x 22.

<u>Novice/New Exhibitors</u>: We are happy to assist you in learning about CFA and showing. Please bring cage curtains, grooming aids, your own litter pans and food to the showhall. People food will be available. Litter will be provided. All cats must be brought to the show hall in some sort of carrier. Please let the Entry Clerk know you are a novice exhibitor.
