**Household Pets:** Will be judged in all 10 rings. Household Pets (HHP) must be over 4 months of age and spayed or neutered by 8 months of age. Declawed cats are NOT eligible for entry.

**Show Hotel:** The show hotel is the Ramada Convention Center, 3321 S. 72<sup>nd</sup> St., Omaha, NE Ph: 402 393 3950. Special show rate of \$74.00 (ask for the Sandhills Cat Show room block). There is no pet fee for this show.

**Entry Information:** All entries must be submitted on an official CFA entry form, printed or typed clearly. On-line entry is available at [www.cfamidwest.org](http://www.cfamidwest.org) All fees must accompany entries. Please make checks payable to **Sandhills-Midlands Cat Show**. No fee will be returned for failure to bench. Per show rule 11.08.a faxed and email entries MUST be paid within ten days of receipt or prior to the start of the show, whichever is first. One half cage is included with each entry. All Security cages require a double cage space: \$25.00 double cage fee applies. Wire benching cages will not be set-up, but will be available for exhibitors use.

**There will be NO SMOKING in the show hall.**

This is a non-vetted show. Cats are expected to be free of fungus and infectious disease. Exhibitors are advised to have their cats vaccinated against Feline Enteritis, Rhinotracheitis, Calici Virus, and Rabies. FELV testing is recommended. All claws must be clipped prior to benching. No kitten under 4 months of age will be allowed in the show hall. Owners of very small kittens may be asked to show registration papers. An exhibitor must own cats and kittens for sale. Litter will be provided, please bring your own litter pans, food, dishes and cage curtains. Single cage sizes are 21"x27"x21". Double cage size is 21"x27"x45". No more than one cat or two kittens may be benched in a single cage. Only cats entered in the show or for sale may be present in the show hall. Reasonable care will be taken to safeguard the property of the exhibitors; however, neither Sandhills Cat Club, Midlands Cat Fanciers, nor Ramada Convention Center will be liable for any loss or damage.

**CFA Information:** All Championship, Premiership and registered Kitten entries will be scored for CFA Regional/National awards. All AAOV, Provisional, and Miscellaneous entries must have a CFA registration number. This show is licensed by The Cat Fanciers Association, Inc. All CFA show rules will be enforced.
