**ENTRY INFO:** Limited to a total of 225, top-ten format. The entry clerk will call collect if your entry is incomplete. You will receive an email confirm indicating receipt of your online entry. IT IS THE EXHIBITOR'S RESPONSIBILITY to confirm online entries with the Entry Clerk. Online entries must be paid within 10 days of sending or start of show (whichever comes first). All mailed entries must be accompanied by full payment, payable to Seacoast Cat Club. Entries not accompanied by full payment will be returned. **HHP entries will not be entered until entry fees are received.** ALL FEES ARE NON REFUNDABLE.

**ENTRIES:** No kitten under the age of 4 months will be allowed in the show hall. Front & back claws must be trimmed prior to benching. Cats should have current immunizations; New Hampshire requires Rabies vaccination for all cats and a health certificate within 10 days prior to the transfer of cats for sale. We reserve the right to change Judges if necessary. All Championship, Premiership, and registered Kittens will be scored for CFA National & Regional awards. If this is your first show, please contact a member of the show committee for assistance, if needed.

**HOURS:** Check-in time: 8:00-9:30 am Saturday. CATS MUST BE BENCHED BY 9:30am SATURDAY. Judging begins at 10:00 am on Saturday and 9:00am on Sunday. Advertised hours: Saturday: 10:00am to 4:00pm and Sunday: 9:00am to 3:00pm.

**BENCHING:** All benching requests must be made at time of entry. No exhibitor may change benching assignments without permission of show manager. Cage dimensions are approx. 21"X23"x21". This is a non-vetted show. No cats or kittens may be confined to carriers either displayed or under cages. Litter will be provided. Please bring your own litter pan and cat food.

**SHOW HALL:** Everett Arena 15 Loudon Rd. Concord, NH 03301 608-228-2784. The show hall is handicap accessible and climate controlled by industrial fans. No cats may be left in the show hall overnight. NO SMOKING will be allowed in the show hall.

**SHOW HOTEL:** Comfort Inn in Concord, NH 71 Hall St. 603-226-4100 (2 miles to show hall). Ask for Seacoast Cat Club rate; \$65+tax+ \$15 pet fee per stay deadline April 26. All rooms have frig, microwave, hot cont. breakfast included; salt water heated indoor pool & hot tub; dry sauna, fitness center. NO airport shuttle. NOTE: Comfort Inn will charge exhibitors for pet damage; exhibitors must sign damage waiver with credit card backup at check-in & damage inspection upon checkout required. All cats must be confined to cages and/or bathroom. Hotel towels cannot be used for cats.

**ALTERNATE HOTELS:** Red Roof Inn in Loudon, NH 2 Staniels Rd. 603-225-8399 (6 miles to show hall). Mention code "B586SEACOA" Rate 2 beds \$75+tax; king bed w/frig & microwave \$80+tax; deadline April 1. No pet fee; cold cont. breakfast included; NO airport shuttle. And Comfort Inn in Merrimack, NH 242 Daniel Webster Hwy. 603-429-4600 (35 minutes to show hall). Ask for Seacoast Cat Club rate \$45+tax+\$15 pet fee per stay; deadline April 1. All rooms have frig, micro-wave, hot cont. breakfast included, free shuttle service for Manchester Airport; hotel renovated in 2007. Damage waiver applies.
