**Entry & Payment Info:** Entries are accepted now. Entry Fees include CFA & Regional surcharges. There are no additional fees for online entry or substitutions. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Star City Cat Fanciers. Returned Check Fee is \$50 plus all bank fees. No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. Check your confirmation for accuracy and contact the entry clerk with any corrections **BEFORE THE CLOSING DATE**. If this is your first show let the entry clerk know and visit <http://www.cfaneewbee>.

**Show Hall:** Berglund Center 710 Williamson Rd. NE, Roanoke, VA Ph: 540-853-2241. The show hall has air condition and heat (as needed) and is handicap accessible; there is no smoking. **No outside food allowed in the show hall.** There is a food vendor and they sell beer. Parking is free: unloading and parking is in the back and there is a ramp to roll carts; there is also an elevator in the front of the building.

**Show Hours:** Check-In: Saturday 7:30 to 8 am. Judging: 8:30 am Saturday; 9 am on Sunday. Advertised Show Hours: 9 am to 4 pm Saturday & Sunday.

**Benching:** Single cage size is approximately 22"x22"x22" and is included with your entry fee. Exhibitors with an odd number of entries using any size security cage are required to purchase an extra 1/2 cage. \*\*EOR fee will be waived for handicapped exhibitors. Litter will be provided, bring cage curtains (or coverings) to cover the sides, top and bottom of cage. Kittens under 4 months are not permitted in the show hall or on the show grounds. No cats or kittens may be left in the show hall overnight. Only benched cats and kittens are permitted in the show hall, none may be confined in carriers.\* Sales cages with paid entry as available.

**Show Hotel:** Holiday Inn Valley 3315 Ordway Dr. Roanoke, VA 24017 Ph: 540-362-4500. Room Rate \$99; you will be asked for a \$50 refundable pet deposit; you will not be charged if the room is left undamaged. **Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or TRN will not be included in the count.

**Household Pets:** All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

**Health:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped prior to benching. Declawed cats are not eligible for competition.
