OWNER'S RESPONSIBILITY: Please verify with the entry clerk that your entries were received.

PAYMENT INFORMATION: Please make checks payable to Sternwheel Cat Fanciers. Post-dated checks will not be accepted. Full payment must accompany all mailed entries. Per Show Rules 6.21 and 6.20, all online entries must be paid in full within ten (10) days of receipt or prior to the start of the show, whichever is first (cash, check or money orders accepted only), and the use of the online entry form is interpreted as an official entry in this CFA show, and your email address on the form is considered to be your signature. No entries will be withdrawn once the confirmation is sent. There is a \$50 fee for any returned checks. **Payments not received within two weeks after the show date, will incur an additional \$50 late fee.**

BENCHING REQUESTS: At least one request per exhibitor is guaranteed, but efforts will be made to honor other requests to the best of our ability. Whenever possible, handicap requests will be benched at no extra charge to the exhibitor.

SHOW HOURS: Check-in will be from 7:30 to 8:30 a.m., advertised hours for the show is 9:00 a.m. to 6:00 p.m.

HOTEL INFORMATION: Directions to the show hall and hotel listings will be sent with confirmation.

TRANSPORTATION: Exhibitors will need to be responsible for their own means of transportation.

FOOD & SUPPLIES: Food service will be at the show hall for exhibitors. Litter will be provided. Please bring your own litter pans and cat food.

SCORING: All entries in Championship, Premiership (except Novices), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices and kittens without registration numbers can contact the entry clerk for a Temporary Registration Number. Novices and kittens without registration numbers will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or a TRN will not be included in the count.

VETTING: The show will be non-vetted. All entries should be inoculated by a licensed veterinarian against feline enteritis, feline rhinotracheitis, calici virus, rabies. Entries should be tested for FeLV and be free of parasites. All claws of entries must be clipped prior to benching.

MISCELLANEOUS: Show management will take reasonable care of cats and carriers, but will not be responsible for damage or loss. The show hall is a NON-SMOKING facility with heating and air conditioning. Benching cage size is 22x22x22 (1/2 cage), this will be provided to you with each entry..
