General: This is a CFA licensed show and all show rules will be enforced. A copy of the current show rules can be obtained at no cost online at www.cfa.org.

Show Hall: Jacob Building, Chilhowee Park, 339 Lakeside Street, Knoxville, TN. Show hall is handicap accessible, has heat and air conditioning. People food is available on-site.

Show Hotel: There is no official show hotel. Recommend Strawberry Plains, Merchants Drive & Papermill Road for pet friendly hotels.

Scoring: All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number. Rosettes will be awarded, and permanent flats will be used in accordance with CFA show rules.

Entry Information: All entries must be typed or printed on an official CFA entry blank or submitted online. All entry fees must be paid according to CFA show rule 11.08a. A \$50 late fee applies to payments not received within 10 days after closing. Make checks payable to Tennessee Valley Cat Fanciers, Inc. (TVCF, Inc) or payments will be accepted until the closing date via paypal, to meloncali@comcast.net and please note include which show the fees are for in the paypal note section. After closing, please pay at the door.

Show Hours: Check-in is from 7:30am until 8:30am. Judging begins promptly at 9am. Advertised show hours are 10am until 5pm. All cats must be present until the completion of judging unless permission to leave is granted by one of the show managers.

Non-vetted Show: All cats should be free of fleas, fungus, mites, or contagious diseases. Front and back claws must be clipped. Declawed cats are not eligible for entry. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. No kittens under 4 months of age allowed in the show hall. Be prepared to show litter registration on "For Sale" kittens.

Supplies and Miscellaneous: Cages are approximately 24" x 24" x 24". Litter will be provided, but bring your own litter pans, food dishes, and cat food. Novice exhibitors, bring cage curtains and grooming aids. Please bring cats in suitable carriers.

Fly Ins: Knoxville's McGhee Tyson Airport is about 25 minutes from the show hall. We are not able to offer pick-up & drop off for exhibitors, car rental is suggested.
