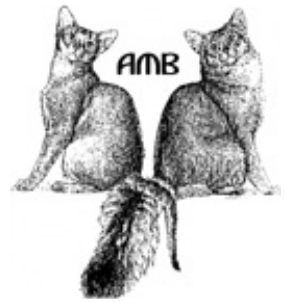

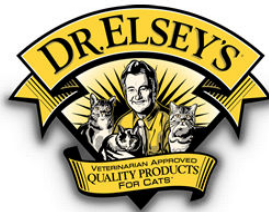

**Entries:** Closing Date is Tuesday July 30, 2013 @ 9 pm CST or when show fills with 225 entries. Email Entry Clerk to confirm receipt of online entries, the Club is not responsible for entries NOT received due to communication errors. **No fax or phone entries.** Per show rule 11.08 a.; Entries *must* be accompanied by all entry fees. Online entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Midwest TGIF Fanciers. Send PayPal payments to [tgifclub@swbell.net](mailto:tgifclub@swbell.net) please note show and entry details. **Odd numbered entries with ANY size security cage must purchase a double cage space.** All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number.

**SHOW HOURS:** Check in 7:30-8:30 am. Judging will start at 9:00 am. Advertised show hours are 9 am to 4 pm. Note: Airport about 35 minutes from the show hall.

**SHOW HALL:** Kennedy Complex 6050 Wells Road (off Tesson Ferry Road) St. Louis, MO 63128 Phone 314-615-5572. The show hall is heated and air conditioned, as needed. Smoking is allowed outside. Show hall is wheelchair accessible.

**AIRPORT:** Lambert St Louis International Airport (STL). Sorry the club can not help with transportation). Airport is about 35 minutes from the show hall.

**RULES:** It is advised that all entries be tested for FELV, and be inoculated by a licensed veterinarian against Feline Panleukopenia, Rhinotracheitis, Calici Virus and Rabies before entry. Claws of all four feet must be clipped prior to benching. **No declawed cats may entered.** All cats must be free of fleas, fungus earmites, and any contagious illness. Show Management reserves the right to cause the removal of any cat from the show hall of any of the above until a licensed veterinarian can make an examination at the exhibitor's expense. This show will be conducted under current CFA rules. A copy of the rules may be obtained by sending \$7.00 to CFA 260 East Main St. Alliance, OH 44601.

**SALES CAGES:** There will be a limit of one double sales cage per exhibitor. To have a sales cage you must have at least one CFA registered entry in the show. Kittens must be at least four months old. CFA litter registrations will be required by show management. There is a maximum of two kittens or one cat per single cage. All sales animals must be in a cage. Positively no cats or kittens will be allowed in carriers under the tables.

**CAGES:** A single cage measures 21"x 21" x 21", a double cage measures 21" x 21"x 42". Bring your own litter pans and food; litter will be provided.

**LIABILITY:** Midwest TGIF Fanciers & Abyssinian Midwest Breeders will take reasonable care to safeguard the property of exhibitors. Neither the clubs, their members or the Kennedy Complex will be liable for any loss or damage. No guard service will be available Saturday evening and all cats must be removed from the show hall during the evening.
