**Entries:** Email Entry Clerk to confirm receipt of online/fax entries, the Club is not responsible for entries NOT received due to communication errors. Per show rule 11.08 a.; Each entry *must* be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Midwest TGIF Fanciers. **ODD NUMBERED ENTRIES WITH ANY SIZE SECURITY CAGE MUST PURCHASE A DOUBLE CAGE SPACE.**

**SHOW HOURS:** Check in 8:30-9:30 am. Saturday 10am to 6pm, Sunday 9:30am to 4pm. Note: Airport 22 miles from show hall.

**SHOW HALL:** Exposition Hall, Indiana State Fairgrounds 1202 38<sup>th</sup> St. Indianapolis, IN 46205 Phone 317-927-7500. The show hall is heated and air conditioned, as needed. Smoking is allowed outside. Show hall is wheelchair accessible.

**SHOW HOTEL:** LA Quinta Airport/Lynhurst (free airport shuttle) 5316 W Southern Ave. Indianapolis, IN 46241 Phone: 317-247-4281. \$50 plus tax, ask for CFA rate, rooms held until 2/19/12. **Alternate Hotels;** the following have numerous locations near the show hall and allow pets; Motel 6 (CFA code 542766), Red Roof (CFA code 526223) and La Quinta (CFA code BRIGHT). Jameson Inn West Indy (free airport shuttle) 3850 Eagle View Dr. Indianapolis, IN 46254. Sorry the club can not provide transportation.

**RULES:** It is advised that all entries be tested for FELV, and be inoculated by a licensed veterinarian against Feline Panleukopenia, Rhinotracheitis, Calici Virus and Rabies before entry. Claws of all four feet must be clipped prior to benching. No declawed cats may entered. All cats must be free of fleas, fungus earmites, and any contagious illness. Show Management reserves the right to cause the removal of any cat from the show hall of any of the above until a licensed veterinarian can make an examination at the exhibitor's expense. All championship, premiership, and registered kitten entries will be scored for CFA regional and national awards. This show will be conducted under current CFA rules. A copy of the rules may be obtained by sending \$7.00 to CFA 260 East Main St. Alliance, OH 44601.

**SALES CAGES:** There will be a limit of one double sales cage per exhibitor. To have a sales cage you must have at least one CFA registered entry in the show. Kittens must be at least four months old. CFA litter registrations will be required by show management. There is a maximum of two kittens or one cat per single cage. All sales animals must be in a cage. Positively no cats or kittens will be allowed in carriers under the tables.

**CAGES:** A single cage measures 21"x 21" x 21", a double cage measures 21" x 21"x 42". Bring your own litter pans and food; litter will be provided.

**LIABILITY:** Midwest TGIF Fanciers will take reasonable care to safeguard the property of exhibitors. Neither the club, its members or the Indiana State Fairgrounds will be liable for any loss or damage. No guard service will be available Saturday evening and all cats must be removed from the show hall during the evening.
