SHOW HOURS:

Check-in time is 7:30-8:30. Show will begin at 9:00am. Advertised hours are 9:00am – 3:00 (Finals). All benched entries will be expected to remain in the show hall until advertised closing time, unless permission is given by Show Manager

No veterinarian inspection prior to benching will be required. You are advised to have your cats inoculated against feline enteritis, feline Rhinotracheitis/Pneumonitis, Calici Viruses, and tested negative FELV for entry. All cats must be free of fungus, ear mites, parasites, and all the above. The show committee reserves the right to remove any cat from the show hall until a licensed veterinarian can pass on all cats. All cats must have their nails clipped prior to benching. According to CFA rules no declawed cats are shown. Reasonable care will be taken of cats and personal property. Neither tornado Alley Fanciers or Frontier Feline Fanciers nor its individual members shall be liable for property lost or damaged. This is a CFA licensed show; CFA rules will be strictly enforced. Show rules may be obtained from CFA. All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing As Household Pets with an Household Pet color class prefix will be scored for CFA awards. The club reserves the right to add judges not named to judge. Kittens under 4 months 24ths of age will not be allowed in the show hall.

There will be NO sale of Cats or Kittens at this show.

Johnson County 4-H Building will not be liable for any loss or damage. The show hall is not air-conditioned, but is heated and handicap accessible. Smoking is outside

SUPPLIES: Litter will be provided. Bring your own litter pans, cat food and water dishes. A single cage is provided with each entry. Single cage size is 21 x 21 x 21; double cage size is 21 x 21 x 45. Bring cage curtains or towels to hang on the inside, top and bottom of cage.
