## **SHOW HOURS:**

Check-in time is 7:30am - 8:30am Saturday. Show will begin at 9:00am on Saturday & Sunday. Advertised hours are 9:00am – 4:00 pm on both days. All benched entries will be expected to remain in the show hall until advertised closing time, unless permission is given by Show Manager. *Vendors are welcome to setup on Friday, February 1st from 12:00 pm until 5:00pm* 

Entries are accepted now. Entry Fees include CFA & Regional surcharges. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Exhibitors may make payment by credit using Square when entering – entry clerk will send invoice with confirmation. No refunds for failure to bench. Make checks payable to Wichita Cat Fancy, Inc. No refunds after the entry clerk has confirmed your entry or for failure to bench. No substitutions after the closing date. Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE THE CLOSING DATE.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

**Supplies:** Litter will be provided. Bring your own litter pans, cat food and water dishes. A single cage is provided with each entry. Single cage size is 22 x 22 x 22; double cage size is 22 x 22 x 45. Bring cage curtains or towels to hang on the inside, top and bottom of cage. No kittens under 4 months of age are allowed in the show hall. A CFA Litter Registration must be presented to show management upon request or kitten(s) must be removed from the show hall immediately. No cats or kittens permitted in carriers under the benching tables. No un-entered cats or kittens may be in the show hall without permission. There may be a maximum of two kittens or one cat per singe (1/2) cage.

Health: No veterinarian inspection prior to benching will be required. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of each entry must be clipped prior to benching. Failure to do so will subject the entry to disqualification. Declawed cats are not eligible for competition. State of Kansas regulations require that all out of state entries have a health certificate issued within 30 days of the show, stating that the cat/kitten is current on its inoculations including rabies. A state official may ask to see this certificate so please be prepared. This is a State of Kansas regulation and law beyond the control of the Wichita Cat Fancy, Inc.

Household Pets: All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

Show Hotel: Show committee has arranged for a block of rooms at the LaQuinta 6335 W. Kellogg Dr. Wichita, KS 67209 316-943-2373

According to CFA rules no declawed cats are shown. Reasonable care will be taken of cats and personal property. Wichita Cat Fanciers, nor their individual members shall be liable for property lost or damaged. The Cotillion will not be liable for any loss or damaged. Smoking is outside. Show hall is heated & air-conditioned and handicap accessible.
