All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. The Region reserves the right to add or substitute judges not named in the show flier should it become necessary.

Cages and Supplies:

Wire cages are available; please advise the entry clerk if you would like to use one. Exhibitors may also bring their own benching enclosures. Use of any size of such enclosure requires payment of "extra half cage" fee.

Litter will be provided; bring your own litter pans, cat food and cat dishes.

NOTE: Per show rule 10.05, No more than two kittens or one cat may be benched in a single space whether entered for exhibition or competition or benched for sale.

Show Hall: The Cotillion Ballroom, 11120 W. Kellogg Ave, is a handicapped-accessible facility that is air-conditioned and heated. There will be a concession stand available for lunch.

Health Information:

This is a non-vetted show. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, caliciviruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All entries must be free of fleas, ear mites, fungus, or any contagious or infectious illness. Claws of all entries must be clipped prior to benching. Declawed cats are not permitted in the show hall. No kittens under the age of 4 months will be permitted in the show hall.
