**Entries:** Properly completed must be submitted by exhibitors in the form of an official CFA entry form or facsimile, or an entry sent online ([www.catshows.us](http://www.catshows.us)) following such entry with all information except signature typed or hand printed. The use of the online entry form is interpreted as an official entry in this CFA show, and your email address on the online entry form is considered to be your signature per CFA show rule 4.05. If using the online entry please confirm receipt with the entry clerk. No phone entries accepted. Each entry, except online entries must be accompanied by full entry fee. All online entries must be paid in full in 10 days of receipt or prior to the start of the show, whichever is first. The club shall charge \$25 for entry fee nonpayment beyond the 10-day limit in CFA show rule 11.08a. All checks must be paid in US funds. Please make checks out to *William Penn Cat Club*. Limit one benching/agent request per exhibitor. *Sorry, no HHPs.*

**Benching:** Entry check-in is at 7-8 am on Saturday. Judging will begin at 9am. No change of benching assignments shall be made without permission of the show manager. All benched entries, with the exception of kittens, must remain in the show hall until the advertised closing hour of 5pm on Saturday. Cage size is approximately 22x22x22.

**Show Hall:** is air-conditioned, handicapped accessible and smoking is not permitted where cats are benched or judged. Food Vendor on the premises—**Absolutely no outside food or drink permitted in the show hall!** Show management will take all reasonable care to safeguard the personal property of exhibitors. However, neither the club, its members, nor the hotel shall be liable for loss or damage to such property.

**Exhibitor Info:** William Penn CC reserves the right to substitute judges in case of illness or emergency. Litter will be provided but no litter pans will be provided—we remind exhibitors to bring their own. All Championship, Premiership and registered Kitten entries will be scored for CFA National and Regional awards. All claws of all entries must be clipped prior to benching. No declawed entries are permitted. Cats or kittens should be clean and free of fungus, fleas, ear mites and any contagious or infectious illness. No kitten under the age of 4 months shall be permitted in the show hall. **The state of New Jersey mandates current rabies inoculations for all cats-** it is advisable to bring your cat's certificate with you. All cats or kittens for sale or lease must be benched in the benching area, and must be eligible for CFA registration. The person offering the cat or kitten for sale must have entry in the show and must ensure and enclosed, secured carrier. No exhibitor may leave cats or kittens in the show hall overnight. By entering all exhibitors agree to abide by the decisions of the judges and show committee and to adhere to CFA show rules. Copies of CFA show rules may be obtained for \$5.00 each from CFA, 1805 Atlantic Avenue, Manasquan, NJ 08736.

**Show Hotel:** Country Inn & Suites, located next to the show hall at 1125 Village Drive at Wade Blvd. Millville, NJ 08332 (856) 825-3100 or (800)456-4000. All cats staying in the hotel **MUST** be tented. Any damages to the room will be charged to you.
