Please pay in advance; you won't have to wait in a socially distanced line to get your catalog, it will be on a separate table. If you are traveling with another exhibitor, please let us know so we can bench you as a "family". If you are bringing someone to help you, please let us know.

Entry & Payment Info: Entries are accepted now. Fees include CFA surcharges. Please confirm online entries with the entry clerk; neither the club nor the entry clerk will be responsible for non-confirmed entries. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Cat Club of the Palm Beaches. PayPal IS available; send payments to tropikoons@mac.com and choose the friends and family option to avoid fees. No substitutions after closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. Check your confirmation for accuracy; contact the entry clerk with any corrections BEFORE CLOSING DATE. **Sorry, no Household Pets.**

Show Hall: Sanford Civic Center, 401 E. Seminole Blvd. Sanford, FL 32771 Ph: 407-688-5000. The show hall is air-conditioned and/or heated as needed and is handicapped accessible. Smoking is not permitted where cats are benched or judged. Free parking.

Show Hours: Check-in 7:30-8:30am; judging will start at 9 am on Saturday; show will start at 8:30 am on Sunday. Exhibitors may leave the show hall when your judging is completed both days.

Benching: Single cage size is approximate 22" x 22" x 22"; and is included with your entry. **Exhibitors with a single entry using any size security cage are required to purchase an extra 1/2 cage.** Clay litter will be provided. Please bring your own litter pans, cat food, and water/food dishes.

Scoring: All entries in Championship (except Novice), Premiership (except Novice) and registered Kittens will be scored for CFA Regional awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

Show Rules: CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$7 from CFA, 260 E. Main St. Alliance, OH 44601. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped prior to benching. Declawed cats are not eligible for competition. All cats/kittens for sale must have valid Florida Health Certificates as required by Florida Law. CCPB will not be responsible if this law is not followed.
