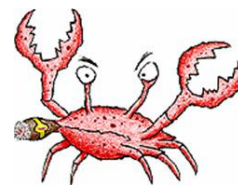

CLOSING DATE

Both Shows close Saturday March 6, 2021 @ 6 pm or when 225 entries have been received
Note **EARLY CLOSING** time is needed to ensure safe benching and show hall COVID planning/setup

COVID-19 Requirements: Release form must be signed for admission. TEMPERATURES WILL BE TAKEN AT THE DOOR EACH DAY. MASKS MUST BE WORN CORRECTLY (COVERING NOSE AND MOUTH) AT ALL TIMES EXCEPT WHEN EATING OR DRINKING (eating and drinking is allowed in the show hall only at your personal benching area). Crab & Mallet Cat Club will follow all city, county, state, and federal covid-19 and related health and safety mandates, restrictions and guidelines in the planning and production of this show. CFA best practices for clubs and participants will also be followed. **These guidelines are subject to change and will be communicated separately.**

Show Hall: 4H building at the Maryland State Fairgrounds, 2200 York Rd, Timonium, MD 21093. The show hall is handicap accessible and heated. Parking is free for exhibitors. People food will be available from 8 am – 4:30 pm (Breakfast, lunch and snack foods) each day via full service concession.

Entry & Payment Info: Entries are accepted now. ** Veteran cat entries may not be used as first or second entries if the exhibitor is also entering pedigree cats or HHPs. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Crab & Mallet. **Returned Check Fee** is \$50 + ALL bank fees. **Late Fee** (all fees not paid in full by 3/24/21) \$50 will be added to fees owed. Please confirm online entries by email with the entry clerk. No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. **Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE CLOSING DATE.**

Show Hours: Check in for Saturday's show: 7:30 - 8:30 am. Check in for Sunday's show: 8 - 8:30 am. Cats not benched by end of check in will be marked absent. Judging starts at 9 am both Saturday and Sunday. Show hours 9 am - 4:30 pm on Saturday and 9 am - 4 pm on Sunday.

Household Pet Entries: All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

Benching: Individual cage size is 22" X 22" X 22" and is included with your entry. **Exhibitors with a single entry using any size security cage are required to purchase an extra 1/2 cage.** Club will provide litter; bring your own litter pans.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

Show Hotel: Holiday Inn 9615 Deereco Rd. Timonium, MD 21093. 1 ½ miles/5 minutes from the show hall. Rate is \$89 /night, call 410-560-1000 to book; use code "CAT".

Other Local Options: Red Roof 111 West Timonium Rd. Timonium, MD Ph 410-666-0380. 1 mile/3 minutes from the show hall. CFA discount code 526223. Quality Suites 10710 Beaver Dam Rd. Hunt Valley, MD Ph 410-584-1001. 3 miles/7 minutes from the show hall. "Pet Friendly" call to inquire about pet fees.

Fly-ins: Baltimore/Washington International (BWI) is approximately 35 miles from the show hall and show hotel. Exhibitors are responsible for their own transportation.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition.

All show rules will be strictly enforced; show rules are available for \$7 from CFA 260 East Main St. Alliance, OH 44601.
