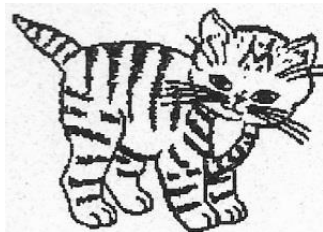
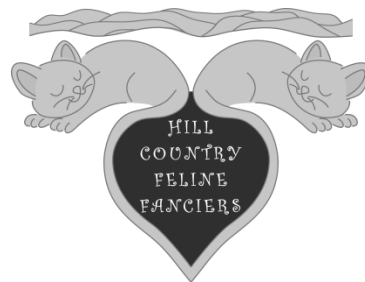

## Food will be available

All benched entries will be expected to remain in the show hall until advertised closing time, unless permission is given by Show Management

- 1) All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or TRN will be included in the count.
- 2) Check your confirmation for accuracy! Please contact the entry clerk with any corrections **BEFORE CLOSING DATE**. "Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first.  
**No refunds after the entry clerk has confirmed your entry or for failure to bench."**
- 3) No veterinarian inspection prior to benching will be required. You are advised to have your cats inoculated against feline enteritis, Feline rhinotracheitis/Pneumonitis, Calici Viruses, and tested negative FELV for entry. All cats must be free of fungus, ear mites, parasites, and all the above. The show committee reserves the right to remove any cat from the show hall until a licensed veterinarian can pass on all cats. All cats must have their nails clipped prior to benching.
- 4) According to CFA rules no declawed cats are shown. Reasonable care will be taken of cats and personal property. Neither Hill Country, or Lincoln Cat Club, nor their individual members will not be liable for any loss or damages. *Smoking only in permitted areas outside. Show hall is heated, air conditioned, and handicap accessible.*

## SUPPLIES:

- Litter will be provided.
- A single cage is provided with each entry.
  - Single cage size is 21 x 21 x 21; double cage size is 21 x 21 x 45.
- Participants to provide.
  - Curtains/towels (to hang on the inside, top, and bottom of cage.
  - Litter pans as well as food and water dishes.
