Registration numbers for kittens must be printed in the catalog for scoring. No exhibition cats.

Benching

Check-in will be Saturday from 7:45 to 8:45 a.m. Advertised show hours are from 9 a.m. until 5 p.m. Saturday. We will try to accommodate all reasonable benching requests. No veterinarian instpection prior to benching will be required. All entries must be inoculated against Rabies, Panleukopenia, Rhinotracheitis, and Calci viruses and tested negative for FeLV. Any entry showing evidence of fungus, fleas, earmites or contagious disease will be asked to leave the show hall. All claws of all entries must be clipped prior to benching. No declawed cats may be shown. Kittens for sale or entry must be four months of age.
