Current CFA Show Rules are available by sending \$7.00 to: The Cat Fanciers' Association, Inc., 260 E. Main Street, Alliance, OH 44601, or they may be downloaded from www.cfa.org/Portals/0/documents/forms/19-20/show-rules.pdf. All entries must be registered with CFA, except kittens and household pets. Kittens must be registered for CFA National and Regional scoring - registration numbers must be printed in the Show Catalog or provided to the Master Clerk. All championship, premiership and registered kittens and household pets will be CFA scored. Sainly City Cat Club, Inc. reserves the right to add judges not named to judge Non-Championship and Non-Premiership classes.

A link to parking information and a map will be sent along with your entry confirmation. Please make hotel reservations early as it is Winter Carnival time. Hotel rooms will be at a premium. Our official show hotel, the Best Western Capital Ridge, is holding a block of rooms for us; phone 651-227-8711. They will have a shuttle to the show hall Saturday only. Rate is \$109 plus \$10 a day to park and \$20 a day pet fee.

It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline enteritis, feline rhinotracheitis, calici viruses and rabies. It is recommended that you bring your cats' rabies certificates in case they are needed. It is also strongly recommended that cats and kittens be tested for FeLV before entry. Any entry from a house or cattery where there has been fungus or any infectious/contagious illness within 21 days prior to the show is prohibited from the show hall. All claws, front and rear, of each entry must be clipped prior to benching. Declawed cats and kittens are not eligible for entry. All Household Pets over the age of 8 months must be spayed or neutered.

No kittens under the age of 4 months will be allowed in the show hall. Exhibitors must have litter registration available in the show hall to verify age of kittens. Cats and kittens not entered in the show, or in prearranged sales cages, will not be permitted in the show hall.

Supplies: Exhibitors should bring cat food, dishes and litter pans for their cats. Litter will be provided by the show. The show hall is heated, but bring warm curtains or towels for the inside of your cage.

Cages: Approximate size is 21" x 21" x 21" (single cage, one-half of a double wire cage, included with entry). Second entry by same owner will be benched in the other half of a double cage, or the other half may be purchased for extra \$25 (noted as extra half cage), as available. It is recommended that if you are only showing one cat, that you purchase the extra half of your cage so your cat will not be right next to someone else's cat. Exhibitors using security cages for a single entry must pay for one extra half cage, as the security cage takes up the space of a double cage. If you are entering 3, 5, or 7 cats, the extra half cage is complimentary.

Ribbons and rosettes will be awarded according to CFA Show Rules.

Reasonable care will be taken for all cats and personal property, but the Show Management cannot be held responsible for anything lost or damaged. Show Management will ask anyone with misbehaving or disruptive children to remove them from the show hall.

The Show Committee asks that benching requests be held to one per entrant. We will try to honor as many requests as space will allow. Requests for end-of-row will be accommodated as space allows, on a first-entered-first served basis. Clerks will be paid in accordance with CFA Show Rules.
